#### IN MEMORIAM

John Kelly Keane, Jr. died on April 14, 2003 at the age of 65. Prior to his recent retirement, he served as General Counsel of the Washington Gas Company. That position capped a distinguished career as a vigorous and innovative leader in the natural gas industry. Jack also will be remembered for his indomitable spirit, warm fellowship, and love of golf.

Jack long was recognized as one of the people who changed the structure of the natural gas industry. It was Jack's advocacy in *Maryland People's Counsel v. FERC (MPC I)*, and *Maryland People's Counsel v. FERC (MPC II)*, where he successfully sought to protect the rights of captive natural gas consumers.

Jack was a graduate of the U.S. Military Academy, West Point, N.Y., and Georgetown University Law Center. He also served as a White House Aide during the Kennedy Administration.

Soon after his passing, the Natural Gas Roundtable adopted a Resolution, which reads in part:

WHEREAS, Mr. Keane throughout his distinguished career has been a leader in the natural gas industry and an advocate for energy policies and programs that have advanced the national interest, and

WHEREAS, Mr. Keane through his good fellowship, wisdom and ethics has been a friend to the Natural Gas Roundtable and many throughout the natural gas industry.

#### IN MEMORIAM

Alan J. Roth died on April 27, 2003 from complications related to Parkinson's disease, at age sixty-nine. Alan enjoyed a long career as an energy law practitioner, first with the Federal Power Commission (now the Federal Energy Regulatory Commission), then at the U.S. Department of Commerce, as a Commissioner of the New York State Public Service Commission, and finally in private practice in Washington, D.C.

Alan Roth received his undergraduate and law degrees from Harvard University. From 1958 to 1969, he worked for the Federal Power Commission, principally on the regulation of natural gas rates. In that capacity, Mr. Roth received numerous honors and awards from the FPC. From 1969 to 1970, Roth was Deputy Director, and then Acting Director, for compliance at the Office of Foreign Investments, U.S. Department of Commerce. From 1970 to 1975, he was Executive Assistant to the Chairman and then a Commissioner of the New York State Public Service Commission, where he worked on a wide array of utility cases.

In 1975, Mr. Roth joined the law firm of Spiegel & McDiarmid, and primarily represented municipally owned electric systems and state agencies on electric, gas, and telephone utility matters. He was a partner with the firm from 1976 to 2002 and was Of Counsel to the firm at the time of his death.

Roth served on the Board of Directors of the National Consumer Law Center from 1978 to 2001 and on the Board of the Energy Bar Association from 1993 to 1995. From 1970 to 1980, he served as Chairman of the Subcommittee on Hearing Procedure of the Federal Energy Regulatory Commission's Advisory Committee on Revision of Rules of Practice and Procedure.

In May 2000, the Massachusetts Municipal Wholesale Electric Company passed a resolution in recognition of Mr. Roth's service. Earlier, he received the Distinguished Service Award of the New England Public Power Association. On June 24, 2002, Alan was recognized by the National Consumer Law Center for his outstanding service.

Throughout his life, Alan Roth worked with great intelligence and conscientiousness. Mr. Roth was noted for his unwavering integrity and sense of fairness. Above all, he was a good friend.
